RESTAURANT GROUP, DBA FIRESIDE GRILLE

ISSUE

Seeking approval from the Village Board for an Off-Premise, Temporary Liquor License for KMZ Restaurant Group, dba Fireside Grille, allowing customers to pay for and pick up bottles of wine from the restaurant for orders placed at a wine tasting event at Rich Harvest Farms on October 10, 2026.

DISCUSSION

Per Title 3, Chapter 2 of the Village Code, liquor licenses are required for all establishments or businesses that sell or serve alcoholic beverages. Establishments must apply annually for license renewal.

Each license classification can be issued as Annual or Temporary, with Temporary defined as up to thirty (30) days per license year (any portion of a day is a full day).

Staff reviewed the liquor license application for KMZ Restaurant Group, Fireside Grille, and found it complies with the Village Code's requirements.
