I hereby agree to all terms, conditions and restrictions written or printed below and to the Sycamore Township Rules and Regulations, including the precautions for the protection of the public and all utilities within the public right-a-way and to any and all installation in and around said pavement openings. If work done under this permit involves or endangers structures belonging to others, I shall immediately notify the owner.

This permit may at any time be revoked or annulled by Sycamore Township for non-performance and/or non-compliance with any of the conditions, restrictions and/or regulations. A performance/guarantee bond to the Trustees of Sycamore Township in the amount of \$1000.00 per lineal foot of pavement opening shall be provided to ensure that all work conforms to the drawings submitted.

At all times during the progress of the work, the permit holder shall provide adequate protection and passage for the traveling public. No road closures shall be permitted. All pavement openings must be filled or plated if they are to be left unattended, all cuts within the roadway shall be backfilled with control density fill or other approved material per the regulations of the Hamilton County Engineer and excavated material must be hauled away from site. All asphalt edges are to be sawed to ensure a clean cut. Pavement must be replaced in kind and all edges sealed.

Plans and/or applications must be approved and permit secured before commencing work. Township regulations require that you notify the Maintenance Department forty-eight (48) hours before starting construction (between 7:30 A.M. and 4:30 P.M.) – at (513) 792-7257.
