RESOLUTION NO. 2009 - 22

**A RESOLUTION SETTING NEW RATES AND FEES FOR EMS AND FIRE DEPARTMENT SERVICES, DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY**

WHEREAS, the Board of Township Trustees desires to set new rates and fees for certain services rendered to the public by the Sycamore Township EMS & Fire Department;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** Resolutions 2000-53, 2007-10, 2007-85 and 2009-15 are repealed in their entirety.

**SECTION 2.** Set forth on Exhibit A are new rates and fees for services rendered by the Sycamore Township EMS and Fire Department. Such rates and fees are hereby adopted in their entirety as the rates and fees to be charged for services rendered by the Sycamore Township EMS and Fire Department.



The reason for the emergency is to provide for the immediate implementation of the fee schedule to be charged for EMS & Fire Department services.
