RESOLUTION NO. 2009 - 89

**A RESOLUTION AMENDING RATES OF PAY AND BENEFITS FOR CERTAIN  
TOWNSHIP EMPLOYEES**

WHEREAS, Resolution 2008-119 establish rates of pay for 2009 for township employees; and

WHEREAS, a new employee is being hired in the road department and the Board wishes to establish a new rate of pay for the new employee;

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** Effective July 15, 2009, the following employees shall be compensated at an annual rate set opposite his name:

Jason Petty                      \$13.00/hour plus uniforms

This rate of pay shall be paid in accordance with the regular pay schedule of the township on and after the effective date. In addition, the employee shall receive all other benefits as provided to full time employees under the Sycamore Township employee handbook.

**SECTION 2** All other provisions of Resolution 2008-119 not amended herein and all previous amendments of Resolution 2008-119 shall remain in full force and effect.

**SECTION 3.** The Trustees of Sycamore Township, upon at least a majority vote, dispense with any requirement that this Resolution be read on two separate days, and hereby authorize the adoption of this Resolution upon its first reading.

**SECTION 4.** Upon the unanimous vote of the Sycamore Township Trustees, this Resolution is hereby declared to be an emergency measure necessary for immediate preservation of the public peace, health, safety or welfare of Sycamore Township. The reason for the emergency is to provide wages in a timely manner to Township employees.






