RESOLUTION NO. 2010 - 25

**A RESOLUTION AGREEING TO COOPERATE WITH THE OHIO DEPARTMENT OF TRANSPORTATION, DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY**

**WHEREAS**, the public interest demands the construction of a sidewalk within the right of way on part of U.S. Route 22 (Montgomery Road) situated in Sycamore Township, Hamilton County, Ohio, and described as the "PROJECT" as follows: installation of approximately 1,995 linear feet of pedestrian sidewalk within the right of way of USR22 (Montgomery Road) from East Galbraith Road to Sturbridge Drive; and

**WHEREAS**, it is recognized by the Ohio Department of Transportation that units of government embrace the policy of providing public sidewalks along some thoroughfares in their jurisdiction; and

**WHEREAS**, it is further recognized that the policy of the Ohio Department of Transportation is to permit the construction of sidewalks in its right of way when the unit of government involved will accept and assume the responsibility for the maintenance, repair and replacement of the sidewalks at such time as it may be required.

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** Under the provisions of the Ohio Revised Code, the Board agrees to cooperate with the Ohio Department of Transportation, hereinafter referred to as ODOT, in the improvement in the following: installation of approximately 1,995 linear feet of pedestrian sidewalk within the right of way of US22 (Montgomery Road) from East Galbraith Road North to Sturbridge Drive.

**SECTION 2.** In return for the permission of the Ohio Department of Transportation to construct the sidewalk, the Board of Township Trustees of Sycamore Township, agrees to accept and assume the responsibility for the maintenance, repair and replacement of the sidewalk at such time it is required.

**SECTION 3.** The Board of Township Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and authorizes the adoption of this resolution upon its first reading.


**SECTION 4.**




