RESOLUTION NO. 2010 - 50

A RESOLUTION RENEWING THE DILLONVALE LIGHTING DISTRICT B

WHEREAS, the Dillonvale Lighting District B which includes the streets of Belfast Avenue, Limerick Avenue, Antrim Court, Killarney Court, Mantell Avenue, Dublin Court, Trebor Drive, Dundalk Court, Tralee Drive, Darnell Avenue, Estermarie Avenue, Longford Drive, Wexford Avenue, and Donegal Drive will expire at the end of 2010; and

WHEREAS, pursuant to Ohio Revised Code Chapter 515, the Board of Township Trustees of Sycamore Township desires to continue the Dillonvale Lighting District B upon expiration of the contracts for the lighting district; and

WHEREAS, a public hearing on the proposed renewal of the lighting district was held on June 15, 2010, all required notices having first been given;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, Hamilton County, State of Ohio:

SECTION 1. The Dillonvale Lighting District B shall be extended and continued for an additional ten years which district shall include the following streets: Belfast Avenue, Limerick Avenue, Antrim Court, Killarney Court, Mantell Avenue, Dublin Court, Trebor Drive, Dundalk Court, Tralee Drive, Darnell Avenue, Estermarie Avenue, Longford Drive, Wexford Avenue, and Donegal Drive.

SECTION 2. The costs of such lighting district shall be assessed against each parcel of real estate fronting on such streets in the amount of nineteen cents (\$.19) per front foot per year.

SECTION 3. The assessment for such lighting shall be paid in ten equal annual installments and shall be paid and collected in the same manner in which taxes are paid and collected.

SECTION 4. This Resolution shall take effect on the earliest date allowed by law.




