RESOLUTION NO. 2011 - 16

**A RESOLUTION SETTING NEW RATES AND FEES FOR EMS AND FIRE DEPARTMENT SERVICES, DISPENSING WITH THE SECOND READING, AND DECLARING AN EMERGENCY**

WHEREAS, the Board of Township Trustees desires to set new rates and fees for services rendered to the public by the Sycamore Township EMS & Fire Department;

NOW THEREFORE, BE IT RESOLVED, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** Resolutions 1995-14, 1998-36, 2003-61, 2005-17, 2007-10, 2007-85, 2009-15, 2009-22, 2010-17, 2011-08 which previously established rates and fees for fire and EMS services are repealed in their entirety.

**SECTION 2.** The rates and fees as set forth on the attached Exhibit A are hereby adopted as the rates and fees for services rendered by the Sycamore Township EMS & Fire Department.



The reason for the emergency is to provide for the immediate implementation of the fee schedule to be charged for EMS & Fire Department services.






