RESOLUTION NO. 2012 - 91

**A RESOLUTION REDUCING SPECIAL ASSESSMENTS LEVIED FOR THE
PURPOSE OF CONSTRUCTING CERTAIN IMPROVEMENTS, DISPENSING WITH
THE SECOND READING AND DECLARING AN EMERGENCY**

WHEREAS, pursuant to a petition filed by the owners of certain property, dated December 3, 2007 (the "SID Petition"), this Board of Township Trustees ("Board") of Sycamore Township ("Township"), Hamilton County, Ohio by Resolution No. 2007-90 adopted December 4, 2007, approved the creation of a Special Improvement District (the "SID") pursuant to Chapter 1710 of the Ohio Revised Code;

WHEREAS, pursuant to a petition filed by the SID and owners of the benefited properties, dated December 13, 2007, (the "SA Petition") this Board of Township Trustees ("Board") of Sycamore Township ("Township"), Hamilton County, Ohio by Resolution No. 2007-101 adopted December 14, 2007, has declared the necessity of acquiring and constructing the improvements described in such Resolution and has adopted the assessments with respect to such improvements prepared and filed with the Fiscal Officer and by Resolution No. 2007-104 adopted on December 18, 2007, determined to proceed with said improvements; and

WHEREAS, in accordance with the Petition, the improvements identified in such Resolution (hereinafter called the "Improvements") have been acquired and constructed on behalf of the Township; and

WHEREAS, the Township has pursuant to Chapters 1710 and 727 of the Ohio Revised Code authorized the assessments be levied and collected for the improvements identified in such Resolution (hereinafter called the "Improvements"); and

WHEREAS, this Board by Resolution No. 2007-104 adopted December 18, 2007, as amended by Resolution 2009-120, adopted on October 1, 2009, levied special assessments against benefited properties and certified said assessments to the Hamilton County Auditor for collection; and

WHEREAS, the Service Agreement entered into by and among the Township, the property owners and National City Bank (the "Service Agreement"), dated June 26, 2007, requires the assessments to be reduced by the amount of service payments in lieu of taxes collected pursuant to section 5709.73 of the Ohio Revised Code and the Service Agreement; and

WHEREAS, the Township has reviewed the amount of service payments in lieu of taxes and other funds to be available during 2012 for the purpose of making debt service payments and

indicating the amount by which the special assessments to be collected should be reduced for the 2013 collection year; and

WHEREAS, this Board determines that the assessments previously levied should be reduced;

NOW, THEREFORE, the Board of Township Trustees of Sycamore Township, County of Hamilton, Ohio hereby ordains:

SECTION 1. That the assessments of the cost and expense of the Improvements, which were previously certified by this Board to the Hamilton County Auditor's Office for parcel number 600-0211-0617-00 and in the amounts as set forth in Exhibit A attached hereto, shall be reduced and shall be levied and collected for collection year 2013 in the amounts set forth on Exhibit B attached hereto. The Hamilton County Auditor and Treasurer are hereby directed to forego the collection of the annual assessment against Parcel Number 600-0211-0617-00 for tax year 2012 to be collected in 2013. This resolution shall not affect collection of the assessment in future years.

SECTION 2. The Fiscal Officer is hereby directed to deliver a certified copy of this Resolution to the County Auditor after its adoption.


SECTION 3. That it is found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code. Any requirement that this resolution be read on two separate days is waived.

SECTION 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of this Township, and for the further reason that the immediate adoption of said Resolution is necessary for the orderly reduction of the assessments; therefore, this Resolution shall be in full force and effect from and immediately after its adoption.




