

RESOLUTION 2014- 66

A RESOLUTION AUTHORIZING A CONTRACT FOR THE 2014 ROAD BLACKMAT RESURFACING PROJECT, DISPENSING WITH THE SECOND READING AND DECLARING AN EMERGENCY

WHEREAS, the Board of Township Trustees is desirous of making improvements to the various roads in the Township by having blackmat installed on certain roads in Sycamore Township (the “2014 Road Blackmat Resurfacing Project”); and

WHEREAS, the Township caused plans and specifications for the 2014 Road Blackmat Resurfacing Project to be prepared; and

WHEREAS, Strawser Construction submitted the lowest and best bid for blackmat installation on the Ohio State Cooperative Purchasing Program; and

WHEREAS, based on the bid by Strawser Construction, Inc. under the State Cooperative Purchasing Program the 2014 Road Blackmat Resurfacing Project has a cost of \$295,596.00;

NOW THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Sycamore Township, State of Ohio:

SECTION 1. The Township Administrator is hereby authorized and directed to contract with Strawser Construction, Inc. to provide for the 2014 Road Blackmat Resurfacing Project as set forth in the plans and specifications prepared by the Township for the project.

SECTION 2. The contract with Strawser Construction, Inc. shall provide that the contractor shall provide and furnish all of the labor, materials, tools, expendable equipment, all utility, insurance and transportation services, and shall contain performance incentives all as required in accordance with the plans and specifications prepared by the Township for the 2014 Road Blackmat Resurfacing Project, which plans and specifications shall be made a part of such contract.

SECTION 3. Subject to additions and deletions contained therein, the contract price with Strawser Construction, Inc. shall not exceed \$295,596.00.

SECTION 4. The Board of Township Trustees of Sycamore Township, by at least two-third vote of all of its members, dispenses with the requirement that this Resolution be read on two separate days and authorizes its passage upon one reading.

SECTION 5.

This Resolution is hereby declared to be an emergency measure, necessary for the preservation of the public peace, health, welfare, and safety of the Sycamore Township. The reason for the emergency is to immediately provide for safe roads and streets in Sycamore Township.


