

**RESOLUTION NO. 2015 - 21**

**A RESOLUTION SUPPLEMENTING 2015 APPROPRIATIONS AND DISPENSING WITH THE SECOND READING**

**WHEREAS**, in order to reconcile budgets and appropriations for calendar year 2015; and

**WHEREAS**, the Board of Township Trustees desires to increase certain appropriations to various accounts, funds, and line items within the current appropriations of the Township; and

**WHEREAS**, attached to this Resolution is Attachment A listing various accounts, funds, and line items showing the Current Appropriations, Supplemental Appropriations, and Final Appropriations for those Line Items; and

**WHEREAS**, the Board desires to increase the 2015 appropriations for those Line Items set forth on Attachment A:

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Township Trustees of Sycamore Township, State of Ohio:

**SECTION 1.** The Line Items and accounts set forth on Attachment A and the Final Appropriations set for thereon for those Line Items are hereby accepted and adopted by the Board as the final appropriations for those Line Items for calendar year 2015. The Fiscal Officer of the Township is hereby authorized and directed to increase the appropriation to the appropriate Line Items and Funds as set forth on the Attachment A.

**SECTION 2.** Any other appropriation amount for a Line Item not amended herein or previously amended shall remain at its last appropriated amount.


**SECTION 3.** The Trustees of Sycamore Township upon at least a majority vote do hereby dispense with the requirement that this resolution be read on two separate days, and hereby authorize the adoption of this resolution upon its first reading.

**SECTION 4.** This Resolution shall take effect on the earliest date allowed by law.




