

SECTION 3. This Resolution shall take effect on the earliest date allowed by law.



Township shall provide

1. Use of hydrants and water.
2. Use of a dumpsite within the township limits.
3. Posting of any residential areas.

Scope of Service:

Sweeping will consist of the removal of gravel, cinder, sand, silt, broken glass, and litter in curbed areas highlighted on a Sycamore Township map. We will make no more than 2 complete sweeping passes in heavily accumulated areas by a properly functioning sweeper.
