# MINUTES OF THE TOWN OF WAYNESVILLE BOARD OF ALDERMEN REGULAR MEETING July 10, 2018

**THE WAYNESVILLE BOARD OF ALDERMEN** held a regular meeting on Tuesday, July 10, 2018 at 6:30 p.m. in the board room of Town Hall, 9 South Main Street, Waynesville, NC.

# A. CALL TO ORDER

Mayor Gavin Brown called the meeting to order at 6:28 p.m. with the following members

present:

#### 1. Welcome /Calendar/Announcements

Mayor Brown welcomed everyone to the meeting. From the events calendar, the following were mentioned:

# Alderman LeRoy Roberson made a motion, seconded by Alderman Gary Caldwell, to approve the minutes of the June 26, 2018 regular meeting, as presented. The motion carried unanimously.

Prior to beginning the call for public hearing, Mayor Brown took the opportunity to remind Board members that Town Manager Rob Hites' annual evaluation was due in the month of July. Members were provided an electronic as well as hard copies for completion. The forms are to be turned in to

Assistant Town Manager Amie Owens by July 20 for a special called meeting to be held immediately prior to the July 24<sup>th</sup> regular meeting of the Board of Aldermen to enter into closed session to complete Manager Hites' evaluation.

# B. CALL FOR PUBLIC HEARING

3. <u>Call for a Public Hearing to be held on July 24, 2018 to consider a map amendment to rezone the</u> <u>120 and 140 Broadview, PINs 8615-69-9255 and 8615-69-8390 from East Waynesville Urban</u> <u>Residential to North Main Street Neighborhood Center</u>

Development Services Director, Elizabeth Teague explained that this was a call for public hearing only. This is a map amendment to rezone 120 and 140 Broadview, PIN 8615-69-9255 and PIN 8615-69-8390 from East Waynesville Urban Residential to North Main Street Neighborhood Center. These two lots currently house an insurance office and an undeveloped piece of property which were pre-existing non-conforming (i.e. grandfathered in) to the current East Waynesville Urban Residential District. The owners would like to sell the properties for conversion to a hair salon. Because this is a change of use, the properties will need to be rezoned to allow the re-use of the property for the zoning designation "personal services." The Planning Board will consider this issue and hold a public hearing at their regular meeting on July 16, 2018.

Ms. Teague noted that the recommendation from the Planning Board would come forward to the Board of Aldermen on July 24, 2018. She referenced the application in the packet from the Cook family. Ms. Teague added that one of the options that the Planning Board discussed was potentially an overlay district. Currently, the restrictions are based on which side of the street the property is located. There is a change in topography and that would have been a more appropriate boundary line. If the recommended overlay district is approved, this would change the existing boundary line. The Applicants are open to the recommendation of the Planning Board. Ms. Teague added that the Planning Board had also discussed a caveat to the request noting that this particular area may be changed with the land use plan update.

Alderman LeRoy Roberson commented that he was concerned that without the overlay requirements, it could open up the area to businesses that may be unsatisfactory to the neighborhood. He agreed that an overlay district would be much more palatable. Ms. Teague reminded the Board that this was a specific request from an established hair salon with the use of the property not changing a great deal. However, she did note that if future changes were made, additional buffering between the district and the neighborhood would occur.

Alderman Julia Freeman made a motion, seconded by Alderman Jon Feichter to call for a Public to be held on July 24, 2018 beginning at 6:30 pm., or as closely thereafter as possible, in the Town Hall Board Room located at 9 South Main Street to consider a map amendment to rezone the 120 and 140 Broadview, PINs 8615-69-9255 and 8615-69-8390 from East Waynesville Urban Residential to North Main Street Neighborhood Center. The motion carried unanimously.

# C. NEW BUSINESS

# 4. <u>Discussion of Boards and Commissions</u>

Mayor Brown explained that the appointment for Boards and Commissions would occur at the next regular meeting. He commented that these boards and commissions do a very important job and that some decisions do not come to the Board of Aldermen. Mayor Brown asked that based on this, would the board wish to consider interviewing the candidates?

Board members agreed that it is important to know the candidates and have confidence in their appointments. Due to the schedules of the Board; however, it is not possible to have everyone participate in interviews. Mayor Brown offered to contact each of the new potential appointees and provide a report to the Board members prior to the appointments at the next meeting.

Mayor Brown noted that the effective date for these appointments would be August 1, 2018.

Alderman Gary Caldwell noted that his concern for the Planning Board was that there were a high percentage of real estate representatives. Ms. Teague added that it is important to have a diversity of expertise on all boards and commissions.

The Board agreed by consensus that the Mayor would contact applicants and that appointments would occur at the July 24<sup>th</sup> regular meeting for an effective date of August 1, 2018.

# 5. <u>Discussion of Special Appropriations</u>

Mayor Brown explained that the special appropriations line item had been approved as part of the Budget process on June 26, 2018. The task at hand was to allocate that amount to those who had applied.

Discussion was held related to whether or not to utilize the numbers provided by Alderman Gary Caldwell, consider the scores from the initial screening criteria, or a combination of both. The goal is to keep the funding level to approximately one cent on the tax rate.

Assistant Manager Owens noted that the initial submission for these appropriations was \$118,000 and the current version sits at \$108,500. The suggestion was made to allocate a total of \$118,000 with a total of \$14,500.00 left in undesignated for future requests from those who may not have initially been funded but whom could petition the board for support in the future.

Alderman Gary Caldwell made a motion, seconded by Alderman Julia Freeman to accept the presented allocations and to increase the undesignated amount to allow for future funding should organizations wish to make requests from the Board. The motion carried unanimously.

Mayor Brown noted that just because an organization requested a specific amount, it was not guaranteed to be funded and noted that most received less than requested.

# Phillip Gibbs 59 Babb Street

Mr. Gibbs made a request to close Belleview Street from East Street to Craven Road on July 27<sup>th</sup> for the Gibbs Family Reunion. This reunion occurs every three years and would take place from 6 p.m. until midnight. Mayor Brown asked Mr. Gibbs to get with Assistant Manager Owens for completion of a special event application and the item would be on the agenda for July 24<sup>th</sup>, but that there should not be any issues with the event.

# G. CLOSED SESSION

Alderman Julia Freeman made a motion, seconded by Alderman Jon Feichter to enter into closed session to discuss Potential Land Acquisition – lease of property adjacent to 33 South Main Street under NC General Statute 143-318.11(a)(5). The motion carried unanimously.

# **Background:**

The owners of two properties located along Broadview Road would like to sell their insurance office to a hair salon. The insurance business has been there since 2008, the year the building was built, and is a "pre-existing nonconforming" use within the EW-UR District. An insurance office falls under the use definition of "professional services," but a "hair salon" falls under the use definition of personal services. Therefore these are distinct uses within the Table of Permitted Uses and the pre-existing non-conformity status cannot carry over to the salon. The properties are across the street from the North Main Neighborhood Center District. The applicant is seeking a rezoning in order to allow the sale of the property for the future use as a salon.

Attached are photos of the surrounding area and the property itself from a street view. The two zoning designations are divided by the centerline of the road. This means that on one side of Broadview, mixed-use commercial is allowed, but on the other, it is strictly residential. In their deliberations of June 18 and July 16, the Planning Board considered several issues:

- Broadview is an example of the concern that arises when district boundaries follow the centerline of streets property on one side of the street is not given the same development rights as property on the other side of the street;
- There is a topographical change along the rear property lines of the properties in question which might be a more appropriate zoning boundary;
- This side of Broadview is a potential overlay district that could allow limited commercial uses, but that would involve additional properties and be a text *and* a zoning map amendment which the Planning Board directed staff to research;
- The property has historically been commercial as a professional office. There is not a great difference in land use impact between a "professional office" and "personal services," in terms of land use impact.
- However, even though the rezoning would accommodate the hair salon which would seem an appropriate re-use of the existing office building, the rezoning would also allow/introduce other types of commercial uses which might be negative to the adjacent residential properties.
- There is a desire to work with this applicant to allow the real estate transaction, but to revisit this area as an overlay district at the August 20 Planning Board meeting.

Research of Haywood County land records shows that this particular area has a history of commercial use. Along this side of Broadview, seven lots, including the properties in question to the intersection of

North Main and Summit, have county tax records that indicate: "land desc. Commercial Secondary." There are two other commercial office buildings at 20 and 62, which were built in 1958 and 1959 respectively. The two residential structures also have the "commercial secondary" identifier in the "land description" line of Haywood County land records.

The Planning Board directed staff to research these lots together for a mixed-use overlay. If the overlay designation were established, the allowance of Professional Business and Professional Service could be permitted, recognizing the existing businesses and past land use. This would also prevent other, more impactful types of commercial uses that are allowed in the North Main Street Neighborhood Center District, into this area and adjacent to residential homes. It would not change any of the other dimensional or other requirements of the underlying residential district.

# 2.6.2 Mixed-Use Overlay District

- **A. Purpose:** The Mixed-Use Overlay District (MX-O) is a zoning overlay district established to permit certain limited mixed-uses within residential neighborhoods.
- B. Applicability: The frontage of locations or blocks shall be identified on the Land Development Map to permit certain non-residential uses as permitted in the Use Table in Section 2.5.3. Such locations are noted as either PC (permitted on any Corner Lot located at the intersection of two publicly-maintained streets) or PL (Permitted in Designated Locations on the Land Development Map).

In the meantime however, the Planning Board voted to support the applicant's rezoning request in order to let the land sale go through. Purpose and Intent Statement for the Zoning Districts in Question:

# 2.3.4 Urban Residential Districts (UR) Purpose and Intent

A. The East Waynesville Urban Residential District (EW-UR) is an urban neighborhood of mostly medium to high density residential development bordering the Waynesville town center. Higher density development is encouraged closer to town with lesser densities found as the district approaches areas with steeper slopes. A number of public spaces are found in this district including the East Street and Vance Street parks. It will be important as new development and redevelopment occurs for connections to be made to such public spaces and throughout the district.

# 2.3.5 Neighborhood Center Districts (NC) Purpose and Intent

A. The North Main Street Neighborhood Center District (NM-NC) is a mixed use district that forms the gateway into town from the northeast. The setting of this district is important as it frames Eagles Nest Mountain at the apex of the hill on North Main and forms a forced perspective to the "center" of the district -- the intersection of Walnut and Main Streets. As a result, maintaining inviting vistas down Main Street and creating an attractive public realm are the objective of many of the standards set forth for this district. Street walls, boulevard trees and sign control will all be important in meeting these objectives as the street is redesigned. Working to keep traffic congestion to a minimum in this area will require the use of rear access drives, side street entrances and shared driveway connections. The uses found in the North Main Street Boulevard District serve not only the surrounding neighborhoods, but all of the Waynesville community and are varied in nature.

# Consistency with the 2020 Comprehensive Land Development Plan

In the <u>Waynesville: Our Heritage, Our Future, 2020 Land Development Plan</u>, the stated Land Use Goal is:

"Promote the orderly growth, development and enhanced land values of the Town of Waynesville by preserving and improving Waynesville's existing neighborhoods, creating more attractive commercial centers, maintaining a strong downtown area, taking steps to reduce urban sprawl and protecting the natural beauty of the community." (2020 LDP, p. 4-2)

Objectives under this goal include:

- "Designate appropriate amounts of land to reflect desired development patterns and to accommodate the projected residential, commercial, industrial, institutional and recreational needs of the Town of Waynesville over the next twenty years." (Page 4-2)
- "Promote infill development in the Town of Waynesville as an alternative to continued outward expansion." (Page 4-4)
- "Work to preserve the important character and scale of each unique area within the larger Waynesville community by building on those elements identified as important to defining each area." (Page 4-5)

Another key goal of the Land Use Plan is to "Maintain and strengthen a broad-based economy in Waynesville comprised of a vibrant and expanding manufacturing, retail, agricultural, services, governmental and construction sectors." (Page 4-19) An Objective under this goal includes:

• Designate and support the development of appropriate amounts of land to meet the needs of the different sectors of the economy. (Page 4-19)

I believe this is a case in which you could argue consistency in either direction....we want to encourage mixed-use in some areas and promote the re-use of land and the economy, but we also want to maintain the integrity of the zoning districts that were established in order to reserve certain amounts of land for certain purposes, including residential. Furthermore, the lots in question together with the other 5 lots that follow Broadview to North Main would seem a potential Mixed-Use Overlay.

# Staff Recommendation

As a stand-alone request, this amendment would allow the sale of a property for a business at hand to re-use the building as it exists now based on several facts:

- 1. This side of Broadview has allowed professional services and already has other office buildings and commercial uses in existence along with residential, and property tax records indicate that these and other adjacent lots have a history of commercial use or designation.
- 2. This property is already commercial and has been an insurance office since 2008.
- 3. This structure faces an automotive service center and warehouse immediately across the street.

There are some cases in which the rights of the property owner to use their property, and the context of a particular lot should be considered in the land use decision. As a stand alone action, this map amendment would not be detrimental to the surrounding area as long as the property remained a hair salon. However, because of other uses allowed in the North Main Neighborhood Center District, I would recommend the Board follow up quickly to consider these lots and possibly others as part of a mixeduse overlay with limits on the types of commercial uses allowed. The Town could establish the overlay and only allow (as a "PL" in the Table of Permitted Uses) professional services and professional offices as the allowable uses. This could have the added benefit of eliminating the pre-existing non-conforming status of the other office buildings along Broadview if those properties were also part of the overlay district. This consideration will be taken up at the August Planning Board Meeting.

# **Requested Actions:**

- 1. Motion *to find/not find* the request consistent with the 2020 Land Development Plan.
- 2. Motion to *approval/deny* the requested map amendment and the attached ordinance.



# ORDINANCE NO. 0-13-18

# AN ORDINANCE AMENDING THE TEXT OF THE TOWN OF WAYNESVILLE LAND DEVELOPMENT STANDARDS

- "Designate appropriate amounts of land to reflect desired development patterns and to accommodate the projected residential, commercial, industrial, institutional and recreational needs of the Town of Waynesville over the next twenty years." (Page 4-2)
- "Promote infill development in the Town of Waynesville as an alternative to continued outward expansion." (Page 4-4)





- Coordinate and manger the merger of the Digital Initiatives Unit and the Special Collections unit into a new Special and Digital Collections unit.). I have made significant improvements to the workflow of both areas. I now supervise four staff members and three student workers across the united areas. We work collaboratively, meeting weekly to review new acquisitions and monograph purchases, and to brainstorm difficult reference requests.
- Since I arrived in 2014, I have led the creation of ten new digital collections in the past three years. As of August 2017, more than 27,000 items were available. These collections receive an average of 5,000 visits per month.
- In 2016, I worked with the University of North Carolina Press Office of Scholarly Publishing Services (OSPS) to publish a reissue of the 1926 book *Twenty Years of Hunting and Fishing in the Great Smoky Mountains*. 




