# 1. Welcome and Announcements

# 2. Adoption of Minutes of March 1, 2017

A motion was made by Ann Melton, seconded by Bette Sprecher to adopt the minutes of the March 1, 2017 meeting as presented. The motion carried unanimously.

#### **B. COMMUNICATIONS FROM STAFF**

# 1. Information on the CLG training in Asheville on Friday, April 21, 2017

Land Use Administrator Byron Hickox said that CLG training would be held at the Center for Craft, Creativity & Design in Asheville on Friday April 21, 2017 from 10:00 am - 4:00 pm. The class registration will be paid by the Town, and Mr. Hickox has arranged for a van for travel to and from the class. Vice Chairman Alex McKay stated he would definitely be attending, and others will let Mr. Hickox know by Friday if they plan to attend.

# 2. Information on historic plaques for the Frog Level Historic District

Mr. Hickox told the Commission that he had sent letters out to twelve property owners (16 contributing properties) concerning buying a plaque for their buildings in the Historic Frog Level District. Two building owners have paid the \$100.00 fee and the orders have been placed for those plaques. He said he has gotten emails from several other owners saying they will be sending their money soon. Alex McKay said he had been doing research on the buildings, and he feels the dates of construction for some of the buildings are wrong on the National Register. Mr. Hickox said that the dates needed to be verified before any more plaques are made.

#### C. BUSINESS ITEMS

#### 1. The historic coloring book project

Mr. Hickox asked the commission to look at a sample historic coloring book from Hendersonville. He asked Mr. Glenn Duerr to give some details on the book. Mr. Duerr had taken the book to Ms. Kris Sylvester, a graphic artist, for a proposal to create the drawings for the coloring book. He has not heard back from her.

The commission discussed what drawings they would like to see included in the book. Several ideas were mentioned including:

The Historic Courthouse Green Hill Cemetery (Funerary Art) Mount Olive Church The Municipal Building A view of Main Street Sulphur Springs Park Historic Frog Level / Train Stain Glass Window of the Baptist Church Shelton House Historic Homes

The Way House
The Hannah Graham House
The Stringfield House
The Smathers House
Woolsey Heights (3 houses)

Ms. Sylvester will be given pictures of the different sites to compile the drawings for the books.

There was much discussion concerning the distribution of the coloring books to fourth grade students in the schools.

# 2. The Spread Out Historic District walking tour booklet

Mr. Hickox gave each member a copy of the National Register Application packet. Mr. McKay and Ms. Melton will be working to verify the listings of National Register of Historic Places.

# 3. <u>Historic Speaker Series</u> (last minute issues, speakers for the May panel, etc.)

The third Speaker Series will be held tomorrow (April 7, 2017 - 4:00 pm) at the Folkmoot Center with Libba Feichter as the speaker. Mr. Hickox said everything should already be in place for the event, and he expects a large crowd.

For the May Speaker Series, a panel will be available to talk about the process of having a property placed on the National Historic Register. The Commission discussed who would participate on the panel. Shawn Leatherwood and Glenn Duerr will definitely participate. Charles McDarris will be in touch with Mr. McKay by the end of the week to let him know if he can participate. This meeting will be held in the Historic Courthouse.

#### D. CALL ON AUDIENCE

Ms. Carol Adams, from Vicinitus Haywood, told the Commission that she had received an ad for her paper for the Waynesville's History and Haunts Walking Tour and wondered if the Commission knew anything about the Tour.
