A. CALL TO ORDER

1. Tour of Exhibit

The Commission was given a tour of the exhibit, "When all God's Children Get Together: Celebrating the Lives and Music of African-Americans in Far Western North Carolina."

Town of Waynesville Historic Preservation Commission Minutes December 06, 2017 The exhibit displayed the African American History in Haywood County. This display was created by students in the History Department's 'Introduction to Museums and Historic Site Interpretation Course' during the Spring of 2016. The students were the creators of this project and were enrolled in the Public History program at Western Carolina University.

The online exhibit draws from materials collected by the Pigeon Community Multicultural Development Center. "Lift Every Voice," was an African-American Project, based in Haywood County, NC.

Two guest speakers and authors were present and both spoke to the Commission.

Ms. Lin Forney, author of <u>Lift Every Voice</u>, spoke first to the group. Ms. Forney gave an account of the history of the Pigeon Community Multicultural Development Center and of the services that it still provides to Haywood County. These services include After-School Programs, Youth Enrichment Programs and some Veteran Services. An emergency food pantry has also been set-up at the center. With year round operation, the center has shorter hours in the fall. The center is largely supported by grants and donations and has a yearly budget of \$75,000 - \$80,000. Ms. Forney is the only full-time staff person.

Ms. Forney's inspiration for her book was to gather stories from African-American Elders from all over the county. Information gathered included that of the oldest African-American, in the community, Mr. John Burnett. Information was also gathered from churches and educators about African-Americans lives and what they did in our community. It was hard to get some elders to talk about the pre-civil rights era and sometimes harder to gather their stories because of previous experiences: taking photographs and not giving any recognition to the elders. She also spoke of the displacement and sometimes attempted genocides.

Money from the sale of her book goes back into projects for gathering more information and putting these into print form.

At this point, Development Services Director, Elizabeth Teague, announced that the Historic Preservation Fund (HPF) grant has been awarded to the Town of Waynesville, a certified local government, for 2017. The grant is entitled Survey of African-American Resources and has been selected for funding to focus on the Pigeon Street Community. A consultant will be appointed and the state will help pull together the information that is gathered. Ms. Teague suggested that the Pigeon Street Community Center and the Historic Preservation Commission combine their efforts for historic and architectural research.

Ms. Ann Woodford, author of <u>When All God's Children Get Together</u> spoke to the group as well. Ms. Woodford is from Andrews, NC but also has a background in Cummings, Georgia. Ms. Woodford spoke of attempted ethnic cleansings. Historic stories gathered included recordings of Ms. Woodford's Father, a historian.

Most of the information in Ms. Woodford's book comes from Cherokee County. She also talked about "sundown" towns and white caps. Churches and schools were often burned. Another topic spoken about was the Wilmington Insurrection and the Greenwood Black Wall Street.

Ms. Woodford added that white people should not feel guilty for what has happened in the past. She also added that racism hurts everyone. We should work to tear down barriers.

Ms. Teague thanked Ms. Forney and Ms. Woodford on behalf of the HPC and the Town of Waynesville for hosting the HPC and for sharing their experiences and research.

Ms. Owen spoke about the possibility of actors from the Cemetery Tour participating in the Speaker Series for 2019.

Commission Member Alex McKay, will send the written descriptions of the various historic structures needed to complete the Historic Coloring Book Project to Byron Hickox. Upon delivery of The Historic Coloring Books they will be given to fourth graders from Junaluska and Hazelwood schools.

Land Use Administrator, Byron Hickox, presented a location map that will be included in The Historic Coloring Book. This map will show the location of the Waynesville Historic Structures.

A motion was made by Board Member Ann Melton, seconded by Board Member William Revis, to adjourn the meeting at 3:55 p.m. The motion carried unanimously.
