Chairman George Kenney called the meeting to order at 4:00 p.m.

1. **Minutes from the August 8th regular meeting**

*Mr. Nick Depaolo made a motion, seconded by Ms. Leigh Forrester to accept the August 8th, 2019 regular meeting minutes with the correction as follows: Page 1, first motion, should read “seconded by Ms. Jessi Stone.” The motion carried unanimously (5-0).*

2. **Minutes from the August 22nd special called meeting**

*Ms. Leigh Forrester made a motion, seconded by Mr. Nick DePaolo, to approve the August 22<sup>nd</sup> Special Called minutes as presented. The motion carried unanimously (5-0).*

3. **Dog show wrap up**

Chairman Kenney thanked everyone for working so hard and said that he felt that the dog show was a success and a good representation for the community. Commission Member Depaolo stated he felt there was a good representation of dogs there as well. The final

fundraiser total was \$1,478. The Commission was pleased with the amount that could be put towards the Plott Hound art piece. They thanked Commission Member Steve Lloyd for the tent this year as it worked in conjunction with HART's event.

**a. What could we do better next year?**

The Commission discussed that the registration process was difficult for citizens to hold the dogs and fill out forms simultaneously. They exchanged ideas to make it easier to register. They also discussed ways to streamline a judges' master list of entries, instead of sorting through a multitude of lists.

**Commission Member Libba Feichter arrived at 4:10 p.m.**

The Commission stated that overall the dog show categories worked well, and they thanked Mr. Jesse Fowler for all his hard work.

**4. Walking Tour Book and website discussion**

Mr. Jesse Fowler advised the Commission that the original timeline was early October and due to single month meetings, this date was unlikely. The Commission agreed that the Mountaineer could still provide a mockup book for the commission to look at without the logo. They agreed on a new time frame to see the book with feedback and November for print. Commission advised that if there were any new logo ideas to send them to Mr. Fowler and he would get them to the graphic designer. They discussed ideas for possible URL's and would also review these with Becky from the Mountaineer. Commission Member Nick Depaolo brought a draft map for review and updates.

**5. Other Business**

Commission discussed the placement of an art piece in the Pigeon Street Community. Commission decided to table the discussion until the Plott Hound art piece was paid off.

**6. Adjourn**

*There being no further business to discuss, Mr. Steve Lloyd made a motion, seconded by Ms. Libba Feichter to adjourn. The motion carried unanimously (6-0). The meeting was adjourned at 4:56 p.m.*
