Ms. Griffin gave an update on the cookbooks. There were two minor changes to be made and Clark Communications printing would start printing the cookbooks. Ms. League asked if she had got few quotes, Ms. Griffin announced that she did get one from HCC and it was going to be double due to the fact they would have to hire more people to come in and assemble the cookbooks. So she went with Clark they were a cheaper rate per cookbook. Several places have been asking about selling the cookbooks.

Ms. Griffin praised the Town of Waynesville Public Services staff and all that they do to help install the pieces of art.

Ms. Griffin wanted to know what the status was on the plaque for the bench. Ms. Buchanan said she would check with Ms. Owens.

There was some discussion on ways to spend some of the money in the account and clarification as to the types of expenditures that would be allowed.
