Nikunj Patel – 644 Sheridan Road – Requests a Pouring Liquor License for his Existing Business to Allow him to have Video Gaming

Mr. Patel explained that he would like to have a pouring license so that he could have video gaming. He has provided a drawing showing how he would remove an isle and close off a small portion up front for the pouring and gaming. He said that his business has been struggling and this would help to bring more people in. He wants to have wine tasting. He told the board that they have a pouring license in other businesses. Trustee Hargett asked Mr. Patel if he knew what the projected revenue would be for the gaming. Mr. Patel told him about \$4,000 a month on average. Trustee McCarthy asked about parking and if that had any effect on it. Mr. Patel explained that there was extra parking in the back that he has asked the landlord if they could use that for employee parking. Trustee Hargett said that his concern was that other Liquor stores, gas stations, laundry mats would ask for pouring licenses for gaming. Trustee Robards asked, at what point do we become inundated with gaming? Trustee McCarthy didn't want to set president for liquor stores to ask for gaming. We've tried to keep gaming at a minimum and he would like to continue to do that. The Mayor told him that we would have to look at the parking and he would get back to Mr. Patel.

#### **PUBLIC HEARINGS**

Jeff McCartney – 102 Old Darby Lane – He came to give the Board an up-date on the HOA for Covenant Courts. He told the Board that they had to start from scratch. They obtained the necessary documents to close the old account that was losing money because of fees. To start a new account, they needed to provide documentation explaining they were an HOA and that they are recognized by the State of Illinois. Unfortunately, all of that documentation is not

readily available because the State has stopped recognizing us 3 years ago. We have been working with an Attorney to try and get the correct EIN number because the old President was using 2 of them. We are trying to figure which EIN number we should be using. We have obtained 3 bids from lawn care services. Once the bills and past bills have been sent out to the HOA members we can take care of the lawn and ponds. We only received partial fees from 2016 and no fees from 2017 or 2018. We have \$19,000 in fees out and once we get them back we should be able to get the ponds in shape. He will keep the Board up to date.
