

**VILLAGE OF WINTHROP HARBOR
 APPROPRIATION ORDINANCE 2017-0-10
 AMENDING ORDINANCE 2016-0-9**

An Ordinance **AMENDING** the Appropriations of such sums of money deemed necessary to defray all necessary expenses and liabilities of the Village of Winthrop Harbor, County of Lake, and State of Illinois, for the fiscal year of said Village commencing May 1, 2016 and ending April 30, 2017.

Be it ordained by the President and Board of Trustees of the Village of Winthrop Harbor, Lake County, Illinois:

Section 1: That the sums hereinafter specified, or so much thereof as may be authorized by law be the same hereby appropriated for the corporate objects and purposes of the Village of Winthrop Harbor, County of Lake, State of Illinois, for the fiscal year commencing May 1, 2016 and ending April 30, 2017.

SECTION 2: That the appropriations shall not be construed as determination or approval by the President and Board of Trustees for the expenditures of the sums so specified, or of the payment of any obligation of liability of such Village, whether fixed, contingent, or otherwise, but shall be deemed only as provision for fund as required by law for the payment of legal obligations of the Village when and as the provision for fund as required for the payment of legal obligations of the Village when and as the bills constructs or other evidence of such obligation have been duly vouched, audited, and approved by the President and Board of Trustees.

That the corporate objects and purposes, and the sums are hereby **AMENDED** and so appropriated therefore, are as follows:

SECTION 4: Any sums of money heretofore appropriated and not heretofore expended or drawn against, now in the Treasury, or that hereafter come into the Treasury of the Village of Winthrop Harbor, are hereby specifically reappropriated for the same general and special purposes for which the sums were originally made or expended in making any insufficiency in any other item or items provided in this ordinance.

SECTION 5: That any unexpended balance of any item of an appropriation made by this ordinance may be expended in making any insufficiency in any other item of appropriation made by this ordinance.

SECTION 6: That should any clause, sentence, paragraph or part of this ordinance be declared by a court of competent jurisdiction to be invalid, such decision shall not effect the validity of the ordinance as a whole or any part thereof other that the part so declared to be invalid.

SECTION 7: That the Village Clerk is hereby authorized and directed by the President and Board of Trustees to publish this ordinance in accordance with the statute in such cash made and provided.

SECTION 8: That this ordinance shall be in full force and effect from and after its passage, approval, and publication as provided by law.
