### Traffic Arrest(s):

On 07/18/2015, an Officer stopped a vehicle within the 100 block of Sheridan Road for a lane violation. The driver, **Gerald L. Thomas**, 44, of Kenosha, Wisconsin was subsequently taken into custody after the Officer confirmed his driver's license had been suspended. Thomas was issued citations for Improper Lane Usage, Operation of an Uninsured Motor Vehicle, and Driving While License Suspended. Thomas was later released by a notice to appear pending a future branch court date.

On 07/18/2015, an Officer stopped a vehicle within the 100 block of Sheridan Road for expired registration. The driver, **Jarcey R.
