Traffic Arrest(s):

On 07/29/2015, an Officer stopped a vehicle near the intersection of Cornerstone Drive and Lewis Avenue for speeding. The driver, **Eliseo Calderon**, 50, of Waukegan was subsequently taken into custody after the Officer confirmed he didn't have a valid Illinois Driver's License. Calderon was issued citations for Speeding and No Valid Driver's License. Calderon was later released by a notice to appear pending a future branch court date.
