Traffic Arrest(s):

On 08/12/2015, an Officer stopped a vehicle near the intersection of 9th Street and Roberts Road for speeding. The driver, **Nericia P. Davis**, 28, of Winthrop Harbor was subsequently taken into custody after the Officer confirmed her driver's license had been suspended. Davis was issued citations for Speeding, No Valid Registration, Operation of an Uninsured Motor Vehicle, and Driving While License Suspended. Davis was later released on scene by a notice to appear pending a future branch court date.

On 08/13/2015, an Officer stopped a vehicle near the intersection of 9th Street and Roberts Road for speeding. The driver, **Zachary D. Lincicome**, 21, of Beach Park was subsequently taken into custody after the Officer confirmed he had a suspended Illinois Driver's License.
