Traffic Arrest(s):

On 08/26/2015, an Officer stopped a vehicle near the intersection of Cornerstone Drive and Lewis Avenue for an equipment violation. The driver, **Nickolas Dominguez**, 45, of Kenosha, Wisconsin was subsequently taken into custody after the Officer confirmed he had a suspended Illinois Driver's License. A search of the motor vehicle was conducted by the Officer and a small amount of cocaine was subsequently seized from the motor vehicle. Dominguez was issued citations for No Rear Registration Light, Driving While License Suspended, and Attempted Unlawful Possession of a Controlled Substance. Dominguez was later released by a notice to appear pending a future court date.

On 08/26/2015, an Officer stopped a vehicle near the intersection of Ravine Drive and Sheridan Road for speeding. The driver, **Tameika S. Miller**, 31, of Waukegan was subsequently taken into custody after failing field sobriety tests. On 08/30/2015, Winthrop Harbor Police Officers were subsequently dispatched related to a possible underage party and loud noise complainant within the 400 block of Russell Avenue. After further investigation conducted by the Officers later resulted in the subsequent arrest of **Kyle D.J. Anthony**, 22, of Beach Park. Anthony had been arrested after failing to provide identification information related to the initial complainant and investigation received/conducted by the Officers. Anthony was later released by a notice to appear pending a future branch court date.
