Traffic Arrest(s):

On 09/10/2015, an Officer stopped a vehicle within the 600 block of Sheridan Road for a registration violation. The driver, **Samantha J. Randall**, 23, of Kenosha, Wisconsin was subsequently taken into custody after the Officer confirmed she had a suspended Illinois Driver's License. Randall was issued citations for Operation of a Motor Vehicle While Registration Suspended and Driving While License Suspended. Randall was later released by a notice to appear pending a future court date.

On 09/10/2015, an Officer stopped a vehicle near the intersection of 9th Street and Roberts Road for speeding. The driver, **Krystle L.
