Traffic Arrest(s):

On 09/19/2015, an Officer stopped a vehicle within the 800 block of Landon Avenue for loud music. The driver, **Briana M. Gentry**, 21, of Kenosha, Wisconsin was subsequently taken into custody after failing field sobriety tests. Gentry was issued citations for Illegal Operation of Sound Amplification System (loud stereo), Fleeing and Attempting to Elude Police Officers, Reckless Driving, and Driving Under the Influence of Alcohol. Gentry was later released by a notice to appear pending a future court date.

On 09/20/2015, an Officer stopped a vehicle within the 1800 block of Sheridan Road.
