### **Traffic Arrest(s):**

On 10/24/2015, an Officer stopped a vehicle near the intersection of 7th Street and Sheridan Road for lane and signal violations. The driver, **Daniel L. Young**, 31, of Winthrop Harbor was subsequently taken into custody after failing field sobriety tests. Young was issued citations for Improper Lane Usage, Operation of an Uninsured Motor Vehicle, Driving Under the Influence of Alcohol, and Driving Under the Influence of Alcohol with a BAC over .08. Young was later released by a notice to appear pending a future branch court date.
