### Traffic Arrest(s):

On 02/10/2016, an Officer stopped a vehicle near the intersection of 9th Street and Lewis Avenue for speeding. The driver, **Ardell Reams**, 44, of Waukegan was subsequently taken into custody after the Officer confirmed he had a suspended Illinois Driver's License. Reams was issued citations for Speeding, Operation of an Uninsured Motor Vehicle, and Driving While License Suspended. Reams was later released by a notice to appear pending a future court date.
