Traffic Arrest(s):

On 12/21/2017, an Officer stopped a motor vehicle near the intersection of 7th Street and Sheridan Road for Unlawful Use of Cellular Telephone. The driver, **Jeffery E. Woolsey was later released by a notice to appear pending a future branch court date.
