### **Traffic Arrest(s):**

On 02/03/2018, an Officer stopped a vehicle within the 700 block of Sheridan Road for a lane violation and failure to yield to an emergency motor vehicle. The driver, **Ryan M. Robinson**, 22, of Winthrop Harbor was subsequently taken into custody after failing field sobriety tests. Robinson was issued citations for Improper Lane Usage, Failure to Yield to an Emergency Vehicle, and Driving Under the Influence of Alcohol. Robinson was later released by a personal recognizance bond pending a future court date.

On 02/05/2018, an Officer stopped a vehicle near the intersection of North Park Avenue and Sheridan Road for Speeding. The driver, **Luis A. Tellez**, 33, of Racine, Wisconsin was subsequently taken into custody after the Officer confirmed he had a suspended Wisconsin Driver's License. Tellez later failed field sobriety tests at the Winthrop Harbor Police Department. Tellez was issued citations for Speeding, Driving While License Suspended, Driving Under the Influence of Alcohol, and Driving Under the Influence of Alcohol with a BAC over 0.08. Tellez was later released by a personal recognizance bond pending a future court date.

### **Unlawful Possession of a Stolen Motor Vehicle:**

On 02/05/2018, an Officer was dispatched within the 1000 block of Franklin Avenue related to a theft of a stolen motor vehicle. The complainant advised some unknown subject took their motor vehicle without consent and left with the motor vehicle at an unknown direction. After further investigation conducted by the Winthrop Harbor Police Department resulted in the subsequent arrest of Dajon L. Hudson, 19, of Zion. This case was later reviewed by the Lake County States Attorney's Office. Hudson was issued a citation for Unlawful Possession of a Stolen Motor Vehicle. Hudson was later transported to the Lake County Jail pending a bond hearing.

On 02/05/2018, An Officer was conducting a follow up investigation within the 900 block of Sheridan Road. The subject, Kelsey L. Larsen, 27, of Zion was subsequently taken into custody after confirming she had an active out of state warrant for her arrest (Wisconsin). Larsen was later transported to the Lake County Jail pending a bond hearing.
